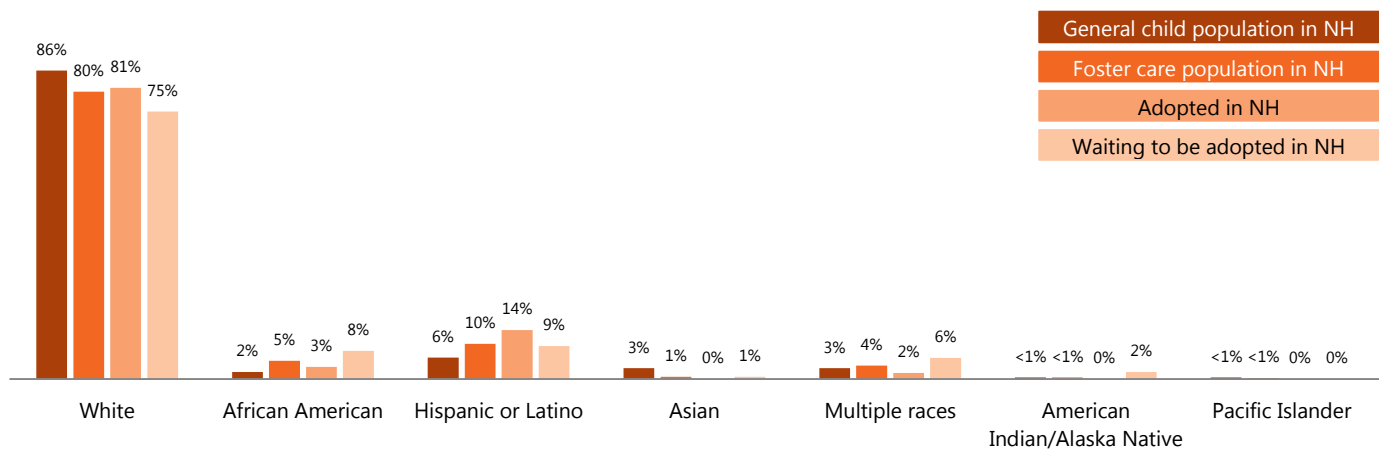

⁵ Does not include children over age 20 or children missing birthdate data; children waiting to be adopted from foster care are age 17 or younger.

⁶ Hispanic children are not included in counts for specific racial groups. Children whose race was reported as unknown are not included. Data for the general child population under age 18 is from the U. S. Census Bureau. This information is publicly available on the Kids Count Data Center (<http://datacenter.kidscount.org/data/tables/103-child-population-by-race>).

⁷ An adoption is considered transracial if the child has two adoptive parents and is not the same race as either parent or if the child has one adoptive parent and is not the same race as that parent.

⁸ In cases where more than one type of adoptive family was selected, Stepparent receives priority followed by Relative, Foster Parent and Non-relative.
